Related Links. After leaving the premises, the plaintiff was arrested for assault by Bostitch. The plaintiff was subsequently convicted for assault.

He sued Bostitch for false imprisonment. The California Supreme Court held that Bostitch was not liable, even though it could be demonstrated that he knew that the use of force was not justified. The court held that "the provisions of the Civil Code governing the liability of individuals for false imprisonment are the same as the liability of

the employer under the doctrine of respondeat superior." The plaintiff was not a party to the contract of employment between Bostitch and himself. Since the employment relationship was one of agency, the court believed that the respondeat superior doctrine did not apply to him. Accordingly, the individual employer, Bostitch, could not be held liable to the plaintiff, although it could be held liable for the false imprisonment by the police officer. The same situation was present in the case at bar. There were two parties who were involved in the instant transaction: Catrone and Pappas. Pappas was not a party to the contract of employment between Catrone and himself. He is the individual who committed the tort of false imprisonment. [3] La.C.C.
